No.50/10/71-(P-III)-UTFI(5)-2018/ 329 In exercise of the powers conferred by Section 3 and 22 of the Capital of Punjab (Development and Regulation) Act, 1952, as adopted by the Punjab Reorganization (Chandigarh) Adaptation of Laws (on State and Concurrent Subjects) order, 1968 and all other power enabling him in this behalf, the Administrator, Union Territory, Chandigarh is pleased to make the following rules further to amend the Chandigarh Estate Rules, 2007 :-


1. These rules may be called the Chandigarh Estate (Amendment) Rules, 2017.
2. They shall come into force from the date of publication in the official Gazette.
3. In the Chandigarh Estate Rules, 2007 (hereinafter called the rules) in Rule 8, after the Table showing the penalty/extension fee, the following proviso shall be added :-

"Provided that in case of Government Departments, the extension beyond initial three years, without charging extension fee, can be permitted by the Chief Administrator."
